## Office.EU Website Privacy Policy

### Introduction

- Erasure – You have the right to request the deletion of your personal data.
- Restriction – You have the right to request restriction of processing of your personal data.
- Objection – You have the right to object to the processing of your data for our mailing list at any time.
- Portability – You have the right to request transfer of your data to another service provider.
