ABSTRACTS REQUIREMENTS

The abstract (maximum two A4 pages) shall be prepared in Microsoft Office Word and edited using the **guidelines** below:

First line gives **THE TITLE OF THE ABSTRACT** (centered, in capital letter, semi-bold 14 pts);

Next line **the name of the author** (first name, last name, centered, semi-bold 12 pts);

Next line – the author's place of work (study), email (centered, standard 12 pts);

Leave one empty line and the body of your abstract should then follow (full justification, standard 12 pts, 1 interval without hyphenation).

Leave one empty line and follow with

References (centered, compiled in the order of cited works, 9 pts).

Margins: left-side margin 30 mm, other margins 20 mm.

The main text should be indented from left by 7.5 mm.

The abstract pages should NOT be numbered.
