- · The collection accepts abstracts in Ukrainian, English, and Polish.
- The volume of the abstract is two full A4 pages, portrait orientation. Borders: top, bottom, left, right 15 mm. Font: typeface Times New Roman, size 14, line spacing 1.0; paragraph indentation 0.5 cm; style Normal.
- •The structure of the abstract: title in UPPERCASE LETTERS, bold; surname, name of the author small regular letters, bold; name of the organization and city in regular font (all aligned in the center of the page); the text of the abstract is printed at 1 interval (alignment along the width of the page), a list of sources (without the word Literature, printed at 1 interval under the text of the abstract, formatting according to the established requirements), references to which are mandatory in the text.
- ·Figures should be arranged as a single object.
- ·Abstracts are not allowed for additional editing, so they should be carefully proofread.
- ·The authors of the abstracts are responsible for the material covered in the abstracts.
- · We accept abstracts with a uniqueness level of at least 75%.
- Students' theses will be published only with the surname, initials, academic degree, and academic title of the scientific supervisor.
- ·Abstracts that do not meet the requirements will not be accepted.
